HIGH SCHOOL SPECIAL PROGRAMS

LIFE SKILLS: Students are referred for Life Skills programming through Brandon School Division Student Services.

EAL: All three high schools provide specialized EAL instruction from Stage 1-3. Crocus and Vincent Massey provide LAL Programming for EAL students will be discussed during the transition process.

Prairie Hope High School: Registration at Prairie Hope High School for students within the Brandon School Division is through a referral process from the other 3 high schools.

Prairie Hope programming is best suited for students who are over 16 years of age and who are pursuing a Mature High School Diploma.

There is no direct entry for students moving from Grade 8 into Grade 9.

HIGH SCHOOL BAND PROGRAMS





- I agree to use only an approved lock on this locker. The school may provide a lock for use, or with school approval I will supply my own lock and register the combination of the lock or a duplicate key at the office. I will not divulge my combination to anyone else.

- I will only use the locker for purposes relating to school and my attendance at school. I understand that I may use the locker to store books, school supplies and equipment, clothing, school sports equipment, lunches and necessary personal items. I understand that nothing else is permitted in my locker unless the principal or vice-principal has permitted it in writing.
- No alcohol, cannabis (marijuana), illicit or non-medical drugs or intoxicating substances or controlled substances, weapons or prohibited or offensive material may be placed in the locker.
- I understand that my permission to use the locker may be terminated if I do not comply with the conditions of use, school and Division policies or rules.
- I understand that it is the responsibility of all members of the school community to keep our schools safe. If I have reason to believe that any locker contains anything that would threaten the safety of other students, staff or any other person, I agree to immediately report the information to a teacher or administrator. I understand that the School Division will keep my name confidential unless required by law to disclose it.
- I agree to keep the locker clean and to remove foodstuffs on a regular basis.
- I understand that I am responsible for cleaning and removing all material from my locker at the end of the year or when I leave the school.

The Brandon School Division authorizes, at the discretion of the Superintendent/CEO or designate, the establishment of school catchment areas, variations thereto to be permitted only if adequate accommodation is available and the Brandon School Division does not incur additional costs to support the attendance of the student at the requested school.

The Board of Trustees is responsible for the establishment of school catchment areas. If changes occur to catchment areas, consideration will be given to requests made for students to remain in their current school subject to the establishment of administrative guidelines.

Assignment to Schools occurs through one of the following 3 categories:

1. **Resident Pupils**

All resident pupils of the Division for Kindergarten to Grade 8 will be assigned to the catchment areas as identified on maps approved by the Division as established by the Board of Trustees

All resident pupils of the Division registering in Grade 9 to Grade 12 will be permitted to register in the high school of choice provided appropriate program accommodation is present, space is available in the program of choice and the student or the student's parent/guardian is prepared to provide transportation if school bus transportation is not provided under existing provisions for busing. Space availability shall be governed by the procedures as outlined and acceptance shall be subject to receipt of registration prior to the annual declared deadline date.

The Superintendent/CEO or designate may assign any student to any school irrespective of the place of residence of the student, if, in their judgement, the welfare of the child or of other children, requires such assignment.

SCHOOL ASSIGNMENT PROCEDURES

When students need to be assigned to their second school selection to ensure that the Grade 9 registration allotment targets are met, the following **guidelines** will apply to the **assignment of students to schools**.

- Every attempt will be made to place students at the school they identify as their first choice.
- If that is not possible as the population of schools are oversubscribed the following will be considered:
 - Students Second School Choice
 - Programming
 - School Proximity
 - Siblings

SCHOOL ASSIGNMENT PROCEDURES

- Student and School Placement Confirmation letters will be mailed to families over Spring Break, beginning on **March 30, 2026**.
- Families requesting reconsideration of school placement should communicate in writing their request and rationale to both the assigned and preferred schools by **April 20, 2026**.
- Students will be able to explore programming at other high schools for their Grade 10 year.

BUS TRANSPORTATION

- Students who live within Brandon School Division boundaries are entitled to bus transportation if they live 2.4 KM or greater from their high school.
