### 1. COMMITTEE ITEMS

#### A. 2026 SCHOOL BUS ORDER

Mr. Labossiere advised that one (1) Bluebird gas school bus and three (3) Bluebird propane school buses are being recommended for purchase using funds from the School Bus Capital Reserve. Mr. Labossiere spoke to the letter received from the Province regarding the 2026 School bus Order.

The cost of the four (4) school buses is \$988,122.14 (including taxes). Mr. Labossiere indicated the cost of gas and propane buses decreased by 2% and that the 2026 price of a gas bus is \$234,200 and the price of a regular propane bus is \$248,200. For 2026-2027, the Division will also be purchasing an accessibility bus in the amount of \$271,900. He added that the Division currently has 48 buses in its fleet, which is comprised of 7 diesel, 1 gas, and 40 propane buses. Mr. Labossiere answered Trustee questions.

The Committee agreed to bring the following recommendation as a motion to the Regular Board Meeting Monday, March 23, 2026:

That the purchase of three (3) Blue Bird propane school buses and one (1) Blue Bird gas school bus for the 2026-2027 school year in the amount of \$988,122.14 (including taxes) be funded by the School Bus Capital Reserve.


